

## HCI Web Privacy Statement

Effective Date: June 2020

Harvest Church International (HCI) respects your privacy and treats the information you provide us, including your Personal Information, with care. This Privacy Statement applies to how HCI collects and uses Personal Information from visitors to [www.harvesteugene.org](http://www.harvesteugene.org) (our "Site") or Other Information available from social media providers in the course of business (our "Service"). It explains how we collect, use and disclose information collected from you and the rights and choices available to you.

### Personal and Other Information

Personal information includes your name, physical address, telephone number(s), and email address. In the case of persons under the age of 18 who attend our services and events, we also collect emergency contact details, and some health information such, as known allergies and emergency contacts, if parents or guardians cannot be reached in a timely manner, in the event of an emergency.

Other information we may use includes data available from social media providers which they collect through automated electronic interactions and includes application usage data, demographic information, geographic or geo-location information and statistical or aggregated data. Statistical or aggregated data does not directly identify a specific person, but it may sufficient to aggregate Personal Information to calculate the percentage of users in a particular zip code or demographic.

In some instances, we may combine Other Information with Personal Information. In such cases, we will treat the combined information as Personal Information.

### Information You Provide to Us

If you provide Information through our Site using our online registration forms, we store the Personal Information you provide to assist us in responding to your requests and, when we receive contributions from you, your Personal Information is used to prepare Annual Giving Statements which are available no later than January of the year after receiving the contributions.

### How We Use Your Personal Information

In accordance with applicable laws, HCI may use your Personal and Other Information for the purposes listed below:

- to send you information you requested
- to contact you in the event of an emergency
- to send you information about upcoming Events or other announcements

### Privacy of Children

HCI knowingly collects Personal Information about children who attend our Services or Events for the protection and care of the child during the Service/Event. This data will be used:

- To promote your child as age or grade appropriate to the next class to be aware of any special needs such as known allergies to assist us to help your child avoid exposure to known allergens.
- To help protect your child in the event of a custody dispute

- In the event of an emergency, to summon first responders and provide them with necessary information to enable them to care for an ill or injured child.
- As necessary to comply with laws requiring mandatory reporting of child abuse or neglect.

**HCI maintains safeguards to protect Personal Information but no internet system can be 100% secure.**
